The distance to the completed portion of the nearest well in the same unit on the "Spacing & Formation" tab is measured to the proposed State North Platte F-36 Fed 25N-20-07. This distance was measured in 2-dimensional space.

Distance from the proposed wellbore to nearest existing or proposed wellbore belonging to another operator, including plugged wells was measured to the 70 Ranch USX BB25-68HN (API Number 05-123-34783). The completed interval of the well is less than 150' from the proposed wells completed interval. A signed Stimulation Setback Consent from Noble Energy Inc. is attached.
