 Field Inspector Actions:  
 On 2-15-2024, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Shane Hall 120 County Road 39 Brighton CO stated the issues were occurring outside of complainants home.  
 On 2-28-2024, I attempted to make contact with the complainant who indicated that on 2-14-2024 complainant experienced a constant vibration at all hours of the day and night at his home.  
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe anything unusual in or around location. The complainant's home is approx.... 1800ft from the Location. I did set up sound study at complainants home. After reviewing data, it appears location is out of compliance with ECMC rules. Operator will need to obtain a low frequency impact study and some type of sound mitigation on site.  
 At time of inspection, I spoke with Drilling supervisor he stated at time of complaint they were drilling and no unusual activity was taking place.  
 Sound study attached to complaint inspection.  
 Weather conditions: Clear  
 Violation of ECMC Rules were observed at the time of the inspection.  
 All information has been reviewed and site inspection information has been submitted to the ECMC for further review.

Corrective Action: For low frequency issues, obtain a low frequency impact analysis and identify control measures. Per rule 423
