### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the cut and capping of isolation valves associated with previously P&A'd LILLI UNIT 16-7. These valves were used to isolate the injection well from the gas gathering system.

Five (5) grab soil samples were collected at the base of the excavation and the areas showing the highest degree of impact during field screening activities at the wellhead excavation. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, one soil samples was analyzed for metals in soil per COGCC Table 915-1. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

A Site Assessment was conducted between March 30, 2022 and April 21, 2023 to delineate impacted media. A total of thirteen soil borings were advanced in the area of impacts. Soil samples were collected and analyzed for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil, metals in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Groundwater was not encountered during site assessment activities.

#### SOURCE REMOVAL SUMMARY

All organic compounds in soil above ECMC Table 915-1 Protection of Groundwater Soil Screening Levels (GSSLs) were successfully delineated through the environmental site assessment. Organic compounds were not detected in soil sample in exceedance of ECMC Table 915-1 Residential Soil Screening Levels (RSSLs). Since arsenic, pH, SAR, and EC were detected in site assessment soil samples above ECMC Table 915-1 RSSLs, a minimum of ten background samples will be collected from five discrete locations to determine if these constituents should be considered contaminants of concern at the site. Additionally, an environmental investigation will be performed to confirm the presence or absence of impacts adjacent to the flowline at a minimum of every 250-ft, per the COA on ECMC document number 403494833. The results of the subsequent background sampling and flowline site assessment will be submitted on a supplemental Form 27.

If the environmental site assessment demonstrates that there are no impacts along the flowline, and if the background soil sampling data demonstrates that arsenic, pH, SAR, and EC should not be considered contaminants of concern, Noble will request a No Further Action (NFA) designation for the site.
