INITIAL ACTION SUMMARY

A site investigation was conducted pursuant to COGCC Rule 911 at the LILLI UNIT T8N-R58W-S4 L01 Tank Battery location.

PROPOSED SAMPLING PLAN

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Eight (8) grab confirmation soil samples will be collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, two (2) soil samples were analyzed for metals in soil per COGCC Table 915-1. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The COGCC Tank Battery and Produced Water Vessel Closure Checklists was utilized and filled out during the abandonment process. A photolog was submitted on the Subsequent Form 27.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

The source was removed through a remedial excavation on May 2, 2023. A total of five confirmation soil samples (SS01@6', SS02@5'-SS05@5') were collected for analysis of TPH C6-36, organic compounds in soil per COGCC Table 915-1, and cadmium per the approved amended sampling plan documented under COGCC document number 403150018. The results of the remedial excavation, including tables, figures, and laboratory analytical reports, are attached to this Form 27.

Laboratory analytical results for the remedial excavation soil samples indicate all samples were below applicable ECMC Table 915-1 soil standards. The cadmium ECMC Table 915-1 Protection of Groundwater Soil Screening Level (GSSL) exceedance seen in decommissioning soil sample, SEP01-DL@4', was removed during the excavation. Based upon field and laboratory data collected during remedial excavation activities, impacted soil in the area of the release has been successfully removed. A No Further Action (NFA) designation is being requested from the ECMC for this project.

REMEDATION SUMMARY

A total of approximately 33 cubic yards of impacted material was removed for off-Site disposal at the Waste Management Landfill in Ault, Colorado under signed Noble waste manifests. A total of approximately 33 cubic yards of imported clean fill was used to backfill the excavation. The final remedial excavation extent measured approximately 15 ft. by 10 ft. by 6 ft. bgs.

Environmental	Based on the information presented, it appears the elevated pH samples appear to be de minimis in quantity or within the range of background pH; therefore, elevated pH may not be associated with E&P activities. It appears that no further remedial action is necessary at this time and the ECMC approves the closure request.
