General Comment:

This is an environmental inspection of the Sack-Hiett #1 well (API 05-123-07782) and Spill/Release Point ID #485295.

On October 17, 2023, Verdad Resources LLC (Operator #10651) submitted an Initial Form 19 Spill/Release Report (document no. 403563609) due to a suspected historical release (visibly impacted soil) discovered on October 16th, 2023, when the historically plugged and abandoned Sack-Hiett 1 well (API 05-123-07782) well owned by Vessels Oil & Gas Company (Operator #93200) was being exposed in preparation for offset abandoned well re-entry required by Rule.

On October 26, 2023, Verdad Resources LLC (Operator #10651) submitted an Supplemental Form 19 Spill/Release Report (document no. 403574055) including photo documentation (Doc #403574068 & Doc #403574069) of the visibly impacted soil within the open excavation around the former well.

The excavation was backfilled at the time of this inspection. Photos attached document site conditions at the time of inspection.
