Comment: This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 10/31/2023. During this inspection, it was observed that the access road still has evidence of road base material, debris remains throughout and the former well location does not appear to have been graded/contoured to reflect adjacent topography (e.g. excavation remains open). Additional reclamation activities are required. Refer to attached inspection photos.
