During this inspection, it was observed that portions of the working pad surface are experiencing varying degrees of erosion degradation (e.g. rill and gully). Stormwater control measures/BMPs are inadequate for this location and the repair/maintenance and implementation of more robust BMPs are required to prevent further site degradation.
