While there, I observed that the tank battery sign emergency contact number decal required replacement and debris around the tank battery. During this inspection the following possible compliance issues were observed: Rule 605.e. with a corrective action date of 5/6/2024 and Rule 606. with a corrective action date of 5/6/2024. A follow up inspection on this site needs to be conducted to ensure the compliance issues have been corrected to comply with ECMC rules.
