Comment: This location does not comply with Rule 1004. During this inspection, it was observed that reclaimed areas are not progressing towards reclamation standards and regulations with evidence of concrete debris, plastic piping, location sign, road base material and areas of bare exposed soils (possibly from flowline removal). The location is not reflective of adjacent reference areas. Refer to attached inspection photos for additional.

Corrective Action:	Perform reclamation in accordance to Rule 1004. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1004 standards.	Date	04/30/2024
