Location # 324139 in Garfield County Colorado. Location is within High Priority/Density/Black Bear Habitat areas & in close proximity to NSO Habitat area. Location is approximately 362 yards from Porcupine Creek. While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1. Fencing - Fencing needs maintenance - post & barbed wire laying on the ground/wildlife hazard with a CA date of 04/19/2024
2. Equipment - Gas meter calibration record not conspicuously displayed at meter with a CA date of 04/22/2024

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
