INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Tank battery decommissioning activities were conducted at the Kirkmeyer 10-25, 9-25 O SA Production Facility location on July 24 and 25, 2023. Field screening of soils was conducted following decommissioning activities, and 8 confirmation soil samples were collected from the former separator (SEP), above-ground storage tanks (AST), partially-buried produced water vessel (PWV), and dump line (DL) locations, as described in a previous Form 27-Supplemental update (Document No. 403563883). Laboratory analytical results indicated that historically impacted soils were present at dump line sample locations DL-B01@4' and DL-B04@4' due to the benzene, TPH, 1,2,4-TMB, and PAH results above the ECMC Table 915-1 soil standards. As such, a Form 19-Initial/Supplemental Spill/Release Report (Document No. 403477439) was submitted on July 27, 2023, and the ECMC issued Spill/Release Point ID 484960. The remaining analytical results for the soil samples collected during facility decommissioning activities were in compliance with ECMC Table 915-1 standards and/or within the range of site-specific background levels or acceptable soil variability for pH. Groundwater was not encountered during facility decommissioning or subsequent over-excavation operations. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 through 5. A topographic Site Location Map is provided as Figure 1. The facility decommissioning soil sample and field screening locations are illustrated on Figure 2. The excavation soil sample locations are illustrated on Figure 3.

PROPOSED SAMPLING PLAN

On September 22 through October 20, 2023, excavation activities were conducted to address remaining soil impacts at sample locations DL-B01@4' and DL-B04@4'. Confirmation soil samples were collected from the sidewalls and bases of the final DL excavation extents, at depths ranging from approximately 6 to 10 feet below ground surface (bgs). Based on analytical results for waste characterization sample DL-B04@4' and the ECMC-approved analyte reduction (Document No. 403563883), the confirmation soil samples were submitted for analysis of BTEX, 1,2,4- and 1,3,5-TMB, TPH, PAHs, and select Table 915-1 metals (As, Ba, Cd, Cu, Pb, Ni, Se), using standard ECMC-approved methods appropriate for detecting the target analytes. Analytical results indicate that constituent concentrations in the soil samples collected from the final DL excavation extents were in compliance with the applicable ECMC Table 915-1 standards and/or within the range of site-specific background levels (x 1.25 for metals).

Additional Investigative Actions

☐ Additional alternative investigative actions described in attached Site Investigation Plan (summary):

On July 24 and 25, 2023, visual inspection and field screening of soils was conducted at 3 sidewall locations within the PWV removal excavation, 1 location at the former enclosed combustion device (ECD), 1 location at the former meter house (MH), 2 locations at the former ASTs, and 3 additional DL removal potholes. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the soil screening locations, and no soil samples were submitted for laboratory analysis from these areas in accordance with the ECMC Operator Guidance for Oil & Gas Facility Closure document. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 through 5. The soil sample and field screening locations are illustrated on Figures 2 and 3. The laboratory analytical reports are provided as Attachment A. The field notes and a photographic log are provided as Attachment B.

Seven (7) background soil samples were collected from undisturbed native material adjacent to the former production facility location, at comparable depths and soil composition to the confirmation soil samples. The background soil samples were submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters and/or Table 915-1 metals using standard methods appropriate for detecting the target analytes in Table 915-1. Analytical results for the background soil samples are summarized in Tables 4 and 5.

SOURCE REMOVAL SUMMARY

From July 24 through October 20, 2023, approximately 560 cubic yards of impacted material were removed from the DL excavation areas and transported to the Front Range Landfill in Erie, Colorado for disposal. The excavation areas were subsequently backfilled and re-graded to match pre-existing site conditions.

REMEDIAL ACTION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Laboratory analytical results indicate that historically impacted soils in the DL excavation area have been remediated to be in compliance with the ECMC Table 915-1 standards and/or within the range of site-specific background levels (x 1.25 for metals). Laboratory analytical results indicated that the remaining constituent concentrations in the soil samples collected during facility decommissioning activities were in compliance with ECMC Table 915-1 standards and/or within the range of site-specific background levels or acceptable soil variability for pH. Hydrocarbon-impacted soil was not observed during field inspection and soil screening activities at the former AST, MH, ECD, DL, and PWV locations. Groundwater was not encountered during facility decommissioning or subsequent over-excavation activities. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
