This location does not comply with Rule 1003. It was observed that interim areas are not progressing towards vegetative standards. While some desirable vegetation was observed in the northern areas, there is evidence of russian thistle and kochia in the early growth stages throughout, and the southern portion of the interim areas consist mainly of russian thistle. Operator will need to perform active weed management and continue to monitor the site until it reaches Rule 1003 standards and regulations. Refer to attached inspection photos.
