Gentlemen:

Donnelly Casing Pulling Company filed with your agency for stripper well category classification (Section 108 of the NGPA) on or about June 1, 1979 for the captioned well. The well had produced less than 60 Mcf per day for the last 90 days prior to the filing.

This well has now produced at an average rate of 70 Mcf per day for the 90-day production period commencing September 1, 1980 and ending November 30, 1980.

Pursuant to §271.805 of the regulations under the NGPA, this letter is our written notice to you, the FERC, and Donnelly Casing Pulling Company (the operator) that the Lousberg 1 gas well located in Section 18-T9N-R56W, Weld County, Colorado is no longer qualified as a stripper gas well based on production for the 90-day production period from September 1, 1980 through November 30, 1980.
