Conducted an on-site inspection at TEP ROCKY MOUNTAIN LLC GIBSON GULCH UNIT 15-30 Pad.  
Location # 323980 in Garfield County Colorado.  
Location is within High Priority/Density/NSO/Black Bear Habitat areas.  
While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1. Equipment - PRV, PRV vent line & rupture disc vent line do not comply with CECMC rules with a CA date of 05/05/2024
2. Stormwater - Culvert/BMP needs maintenance with a CA date of 05/13/2024

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
