INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BAKER STATE B36-11 wellhead cut and cap and flowline abandonment. The wellhead was cut and capped per ECMC rules. Approximately 300' of flowline was removed; however a portion of the flowline was abandoned-in-place due to field constraints and the ECMC was notified on Form 44 Document Number 403346651.

Pursuant to ECMC Rule 911 site investigations will be conducted pertaining to the BAKER STATE B36-11, BAKER STATE B36-12, CLYNCKE STATE B36-25, and CLYNCKE STATE B36-20 flowlines.

Four (4) grab soil samples were collected at the BAKER STATE B36-11 wellhead excavation (1), the flowline terminuses at the wellhead (1) and separator (1), and the flowline cut-point of abandonment. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron.

Soil samples will be collected along the flowline paths at any points of directional change. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (C6-C36), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron.

All samples collected were/will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
