INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the RICHTER USX AB27-13 wellhead cut and cap and flowline removal. Approximately 1418' of flowline was removed. The wellhead will be cut and capped per ECMC rules. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were collected along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. A grab confirmation soil sample was collected at the wellhead excavation base. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

OPERATOR COMMENT

Lab analysis shows no evidence to support a the occurrence of a spill or release at the location since all organic and inorganic constituents, excluding pH in a single sample, present in de minimis amounts, were in compliance with the Table 915-1 concentration standards. Further VOC and SVOC concentrations were all "non detect". Therefore outstanding pH concentrations are unlikely to be related to oil and gas production activities. Operator is requesting to leave pH slightly outside the Table 915-1 concentration standard range in place without additional delineation.
