 On 05/23/2024 at approximately 08:29 hours, I, Compliance Specialist, Wayne Smelser Conducted an on-site inspection at TEP ROCKY MOUNTAIN LLC CS\_Wasatch Compressor Station. Facility # 467146 in Garfield County Colorado.  
 Location is within High Priority/Density/Black Bear Habitat areas/Bald Eagle Roost Site & in close proximity to NSO Habitat area.  
 Location is within Rule 411a Surface Water Intermediate Buffer.  
 Location is approximately 418 yards from Rule 411b Generalized External Buffer.  
 Location is approximately 424 yards from the Colorado River.  
 While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

- Equipment - 2 PRV vent lines lack caps/do not comply with CECMC pressure safety device rules with a CA date of 05/31/2024
- Stormwater - Chemical tote on location lacks BMP's/does not comply with CECMC Stormwater rules with a CA date of 06/08/2024

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
