On 5/13/2024 at approximately 11:20, Compliance Inspector Matthew Morris conducted a follow-up inspection at GUNNISON ENERGY LLC, HOTCHKISS FEDERAL 12-89-612S89W/20SWNW at Location ID #334446 in Gunnison County, Colorado.

Normal production operations were observed.

During the inspection, the following compliance issues were observed:

- 1) Stored supplies/equipment near tank battery
- 2) Unused equipment near tank battery
- 3) Open-ended line poses wildlife entry hazard
- 4) Unsecured separator hatch poses wildlife entry hazard
- 5) Storage tank wall/chime is corroded

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
