Comment: The access road was mostly pre-existing and the location has been recontoured. The upper portion of the location is establishing perennial vegetation well but the lower portion is not and consists of areas of weeds. The berms along the lower portion have eroded and must be repaired or regraded. The lower portion of the location will need to be reseeded and stabilized. The noxious weeds (field bindweed) at the location will need to be controlled.
