Hi Lexi,

I previously consulted you (in March 2024) about upcoming P&A work at the Oskarson wells. This work was initially planned to begin in August, after the eagle nesting season. However, since the nearby eagle nest (Sullivan 2 Ditch Nest) is currently unoccupied, we would like to begin earlier to complete as much work as possible before the next nesting season begins on December 1st.

Please let me know if CPW is ok with the plan to proceed prior to August 2024 and/or if you have any questions. Thank you!


