This location is within or in close proximity to a Parks and Wildlife (CPW) District and Black Bear area with High Priority, NSO, Density and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issues observed during Insp. #702501447 on 6/13/23. All Corrective Actions have been resolved.

While there during normal operations the following compliance issue was observed:

1. Gas calibration out of date.
2. Stained soil.
3. Relief riser missing cover.
