On 6/10/2024 at approximately 11:18, Compliance Inspector Dusty Popejoy conducted an on-site inspection at Caerus Piceance LLC Parachute 697-28C at Location ID #335510 in Garfield County, Colorado.

This location is within or in close proximity to, a CPW Density/High Priority Habitat, Black Bear, NSO Habitat, or Wildlife Management area. Normal production operations were observed.

During the inspection, the following compliance issues were observed:

- 1) Equipment - Entry door on separator open to wildlife, refer to photos with a CA date of 6/19/2024
- 2) Tank battery - Multiple load lines on tanks open ended, refer to photos with a CA date of 6/19/2024

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
