<p><b>FINAL RECLAMATION</b></p> <p>Inspection #696205429 observed that the Location has met a uniform, perennial vegetative cover pursuant to 1004.c.(2) requirements. Comments within the FIR directed Operator to remove the perimeter fence, and to submit a Form 4 with documentation showing removal.</p> <p>No Form 4 was submitted therefore a follow-up inspection was performed.</p> <p>It was observed in this inspection that the perimeter fence remains. Noxious weeds (Musk thistle) were also observed on the Location; a patch of about 20-30 thistle rosettes were observed along the eastern end of the Location. Individual thistle rosettes also observed spread through the central areas of the Location as well as the reclaimed access road. Weeds not observed along the western areas of the Location.</p> <p>Additional weed management efforts are required.</p>	trujilloam	06/10/2024
