A site investigation will be conducted pursuant to COGCC rule 911 at the HALEY GUMESON 1 BATTERY pit. The pit was historically back-filled. Soil samples will be taken and analyzed per Table 915-1 to ensure that this pit does not require any remediation prior to final reclamation on this location.

Two grab soil samples were collected for analysis analyzed by a certified laboratory for TPH C6-36 and organics. Additionally, soil sample SB-1 8FT was also analyzed for SAR, EC, and pH.

The source was removed through mechanical excavation. Grab soil samples were collected to laterally and vertically define impacted media above ECMC standards. Soil samples were analyzed for analysis of Table 915-1 metals, organics, TPH C6-36, EC, SAR, pH, and boron.

Arsenic, pH, and SAR remain in situ above ECMC standards. Background samples will be collected of the oil and gas location in non-impacted native soils.
