INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the GUTTERSEN STATE CC20-12 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 1241' of flowline was removed.

Four (4) grab soil samples were collected at the wellhead excavation (1), flowline terminus at the wellhead (1), and flowline directional changes (2). Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. One (1) grab soil sample was collected during the facility decommissioning assessment and was reported under Rem. # 31580 (Form 27 Document Number 403656558). Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A background sample was collected off-pad from similar lithographic soil near the wellhead for arsenic and selenium analysis. Residual arsenic and selenium at the site appear less than and/or consistent with background comparison and do not appear to warrant additional sampling. Additional backgrounds (5+) will be collected from soil of native/similar lithographic material to further compare residual barium, lead, and pH, as needed.

OPERATOR COMMENT

This Form 27 is being submitted for Gutttersen State CC #20-12. In the absence of any elevated hydrocarbons, and with consideration to all soil suitability parameters being in compliance with ECMC Table 915-1, the site is not indicative of a release. However, due to the presence of slightly elevated metals results in the flowline samples, and in the absence of background samples, Noble is proposing additional sampling be conducted to determine if elevated levels of barium, arsenic, lead, and pH are indicative of native soils. Final wellhead decommissioning documentation will be provided on a Supplemental Form 27 upon completion of further site characterization or site remediation. Groundwater was not encountered during decommissioning or site assessment activities.
