INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the GIBSON 11-9 wellhead cut and cap. The wellhead will be cut and capped per ECMC rules.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the GIBSON 11-9 flowline removal. Approximately 1633' of flowline will be removed. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

One (1) grab soil sample was collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

OPERATOR COMMENT

This Form 27 is being submitted for Gibson #11-9. Analytical results for the samples collected at the well head removal yielded no hydrocarbon detections. There were, however, detections of metals (arsenic and barium) above the ECMC Table 915-1 RSSLs and above the background sample. Selenium was also detected, but above the 915-1 GSSL standard and background levels. As such, Noble is requesting further background delineation sampling be conducted to further delineate the values of arsenic, barium, and selenium in the soil.

Groundwater was not encountered during decommissioning or site assessment activities.

The assessment of the flowline removal is pending implementation and reporting of that event. Final decommissioning documentation will be provided on a Supplemental Form 27.
