On Tuesday, 07/02/2024, Inspector Kirby Burchett, conducted a follow up field inspection at Argali Exploration Company on the Federal-Blue Gravel 1-23 well, Location #312878, in Moffat County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District with High Priority, NSO, Density and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issues observed during Insp. #702501394 on 5/31/23, Insp. #702501889 on 9/20/23, and Insp. #715500169 on 6/5/24. The following Corrective Actions are unresolved and original due dates will remain:

1. Production tank missing required information.
2. Weeds.
3. Insufficient tank berm.
4. Open ports on top of tank.
