On Monday 6/11/2024, I, Inspector Scott Ramsey, conducted a routine inspection at KPK McCallum 19, at Location # 324580 in Jackson county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife black bear Management and Density habitat.

During this inspection the following possible compliance issues were observed:

1. No evidence of any storm water controls to prevent sediment migration or tracking BMP's to prevent sediment from location being transported from location.
2. Belt guard missing from pump jack
3. Well head signage lacking information
4. Load line missing cap/bull plug
5. Lacking tank battery signage
6. Some weeds
