## **OPERATOR COMMENT**

Summit Midstream plans to drill this site for delineation purposes in Summer 2024. Summit plans to advance four borings around the excavation (north, east, south, west) and sample at the approximate depths of impacts previously observed.

Based on previous results, summit requests the reduced analyte suite of EC, SAR, Boron, and Arsenic. The pH exceedances observed in previous samples were below local background concentrations.

Please see the attached map for the approximate boring locations. The exact location of these borings may have to be adjusted in the field due to local conditions.

In addition, Summit plans to advance an additional boring in a native non-disturbed area and collect additional background sample(s).
