Dear Ms. Barrett and Mr. Gibler:

The Colorado Oil and Gas Conservation Commission (COGCC) has adopted guidelines and procedures regarding activities affecting the surface. These rules stipulate an affected surface owner must be given notice in writing by an operator at least thirty (30) days prior to drilling an oil and gas well.

HS Resources, Inc. (HSR) intends to begin operations to drill the HSR-Gibler 11-3A oil and gas well upon approval of title, receipt of permits and prior to August of 2000. It is your responsibility to notify the tenant farmer, if applicable, of this proposed operation.


