During this inspection, it was observed that the former tank battery location does not appear to have been recontoured and graded to match adjacent topography with a trench/depression observed on the western edge of the former disturbance area. It was also observed that the former disturbance area is predominately undesirable vegetation (e.g. kochia). Additional reclamation activities are required. Refer to attached inspection photos.
