INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the McHale 2-5 wellhead on February 22, 2024. Groundwater was not encountered in the cut and cap excavation area. Soil screening around the well and associated pumping equipment was conducted following cut and cap operations, and a soil sample (WH-B01@6') was submitted for laboratory analysis. Removal of the flowline associated with this wellhead was initiated on February 22, 2024. A soil sample was collected from the location where the flowline riser was disconnected at the wellhead (FL-B01@4') and submitted for laboratory analysis. The soil samples were submitted for laboratory analysis of the full Table 915-1 analytical suite. Laboratory analytical results indicated that the lead (Pb), pH, and/or sodium adsorption ratio (SAR) results for samples WH-B01@6' and FL-B01@4' exceeded the Table 915-1 standards and site-specific background levels (x1.25 for metals). As such, 2 verification soil samples (WH-B01R@6' and FL-B01R@4') were collected on March 18, 2024, and were submitted for laboratory analysis of Pb, pH, and/or SAR only, to confirm the initial results. Analytical results for the verification samples confirmed that the Pb and pH results exceeded the Table 915-1 standards and site-specific background levels (x 1.25 for metals). As such, Form 19-Initial/Supplemental Spill/Release Report (Document No. 403739881) was submitted on April 3, 2024, and the ECMC issued Spill/Release Point ID 486440. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 through 5. The soil sample and field screening locations are illustrated on Figure 1. Excavation and/or site assessment activities to address remaining soil impacts have not yet been initiated and will be summarized in a forthcoming Form 27-Supplemental update. Additional flowline removal activities are pending and will be summarized in a forthcoming Form 27-Supplemental update.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

On February 22 and March 18, 2024, a total of 4 confirmation and verification soil samples were collected from the base of the cut and cap excavation area, and from the location where the flowline riser was disconnected at the wellhead, as described above. Analytical results indicate that impacted soil remains at the former wellhead/flowline riser location due to Pb and pH. The remaining analytical results for the confirmation/verification soil samples were in compliance with Table 915-1 standards and/or within site-specific background levels (x1.25 for metals). Excavation and/or assessment activities to address remaining soil impacts at the former wellhead/flowline riser location have not yet been initiated and will be summarized in a forthcoming Form 27-Supplemental update. Based on the analytical results received to date, future confirmation soil samples will be submitted for analysis of BTEX, TPH, TMB, PAHs, pH, SAR, and select Table 915-1 metals (As, Ba, Cd, Cu, Pb, Ni, Se, Zn).

Proposed Groundwater Sampling

Groundwater has not been encountered during the wellhead cut and cap or flowline riser removal operations completed to-date. If groundwater is encountered during forthcoming excavation and/or site assessment activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4- and 1,3,5-TMB, using standard methods appropriate for detecting the target analytes in Table 915-1.

☐ Additional alternative investigative actions described in attached Site Investigation Plan (summary):

On February 22, 2024, field screening of soils was conducted at 4 sidewall locations within the cut and cap excavation area, and 4 locations at the ground surface adjacent to the excavation. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the soil screening locations, and no soil samples were submitted for laboratory analysis from these areas, in accordance with ECMC Operator Guidance. On February 26, 2024, a soil gas survey was conducted at 5 soil vapor points (SVP01 - SVP05) installed adjacent to the former wellhead following cut and cap operations. GEM 5000 field readings were non-detect for methane at all 5 soil vapor points. The SVP locations are illustrated on Figure 1. The SVP screening results are summarized in Table 6. The laboratory analytical reports are provided as Attachment A. The field notes and a photographic log are provided as Attachment B.

Twenty-two (22) background soil samples were collected from undisturbed native material adjacent to the wellhead cut and cap excavation area, at comparable depths and soil composition to the confirmation soil samples. The background soil samples were submitted for laboratory analysis of Table 915-1 metals and the Soil Suitability for Reclamation Parameters, using standard ECMC-approved methods appropriate for detecting the target analytes in Table 915-1. Analytical results for the background soil samples are presented in Tables 4 and 5. The background soil sample locations are illustrated on Figure 1.

Historically impacted soil remains in the wellhead/flowline riser excavation area due to Pb and pH. Excavation and/or site assessment activities to address remaining soil impacts at the former wellhead/flowline riser location have not yet been initiated, and no soils have been removed from the site to date. Impacted soils will be removed and transported to a licensed disposal facility in accordance with Rules 905 and 906. Disposal records will be kept on file and available upon request.

Excavation and/or site assessment activities to address remaining soil impacts at the former wellhead/flowline riser location have not yet been initiated, and will be summarized in a forthcoming Form 27-Supplemental update. Based on the analytical results received to date, future confirmation soil samples will be submitted for analysis of BTEX, TPH, TMB, PAHs, pH, SAR, and select Table 915-1 metals (As, Ba, Cd, Cu, Pb, Ni, Se, Zn). Additional flowline removal activities are pending and will be summarized in a forthcoming Form 27-Supplemental update.
