ECMC Inspection Report Summary

On Monday, 08/05/2024, Inspector Kirby Burchett, conducted a follow up field inspection at TEP Rocky Mountain LLC on the Federal RG 41-18-297 Pad, Location #316591, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District & Wildlife Management Plan with Black Bear, High Priority, NSO, and Density Habitats.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issues observed during Insp. #702501009 on 3/15/23 and Insp. #7025001718 on 8/9/23. The following Corrective Actions are still unresolved and original due dates remain:

1. Debris
2. Wellhead sign not displayed.
3. Soil staining at chemical tank and misc. wellheads.

Refer to Inspection Photos for observed compliance issues.

While there during normal operations the following compliance issues were observed:

1. Illegible labels on chemical tanks.
2. Relief vent risers missing protective caps.
3. Open end load line.
4. Production tanks missing required information.
5. Review of production records indicate operator is delinquent in submitting monthly production reports.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
