Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

Laboratory analytical data indicated a historical release was discovered at the wellhead flowline riser during the UPV 13-1014 flowline decommissioning. One soil sample, FL01R-W, exceeded ECMC standards for toluene at 3.3 mg/kg, ethylbenzene at 4.4 mg/kg, total xylenes at 55 mg/kg, 1,2,4 trimethylbenzene at 28 mg/kg, 1,3,5 trimethylbenzene at 15 mg/kg, naphthalene at 2.2 mg/kg, TPH at 5,900 mg/kg, 1-methylnaphthalene at 0.265 mg/kg and 2-methylnaphthalene at 0.486 mg/kg. A supplemental Form 27 will be submitted for remediation project number 32589 detailing the remedial site plan, document number: 403831329.
