SUNDRY NOTICES AND REPORTS ON WELLS

INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

Before workover this well was producing 1 barrel oil and 36 barrels water per day from the 1st Dakota "D" Sand through casing perforations 4978'-4986'.

Squeezed off casing perforations 4978'-4986' with 150 sacks regular cement. Drilled cement out of 5 1/2" OD casing and cleaned out to 5097'.

Perforated 5 1/2" OD casing in 3rd Dakota "J" Sand 5089'-5094' with 20 shots. On July 21, 1960, treated these perforations with 200 gallons mud acid followed with 10,000# 20-40 sand and 10,000 gallons frac oil with 300# Dowell 4-12 gyp inhibitor.

After recovering all load oil, pumped 24 hours for 24 barrels new oil, no water, and 50,000 cubic feet gas. Date of recompletion was July 27, 1960.
