Comment: Desert Eagle Operating (DEO) endeavors to operate in a manner that protects public health, safety, welfare, the environment and wildlife resources by complying with all the rules and regulations of the ECMC. The flowline right of way has traversed for ripping, seeding, water application, and erosion mitigation, Desert Eagle Operating personnel, contractors, and other parties associated with the location have been instructed on Rule 1002.3. and to the extent possible not travel outside of the roadway. Areas of the location were prepared and seeded; however, sparse germination has been attributed to several factors: lack of rain, lack of topsoil/soil amendments, and remaining areas of heavily compacted soils. DEO is preparing to address these issues with additional soil ripping, applying additional topsoil, and reseedling. The persistent draught has been impeding progress.
