General Comment:

This is a joint inspection with CDPHE Water Quality Control Division. CDPHE was conducting a construction stormwater inspection of Crestone Peak Resources Operating LLC locations and ECMC staff attended. ECMC will not issue any corrective actions that would also be a corrective action for CDPHE.

The below are potential observations being addressed by CDPHE.

- Inadequate installation of wattles across the location
- Bare areas of soil throughout interim areas in seeded areas
- Concrete waste observed outside of containment
- Sediment and debris accumulation in rip rap and culverts
- Earthen berm was not compacted along the South perimeter of the pad

Comment:	Weed debris in the form of tumbleweeds, new germination and full stature plants were observed throughout interim areas within the permanent location fence as well as outside along topsoil stockpiles. Tumbleweeds are a troublesome annual non-native weed that easily breaks off at the stem. Operator failed to control and manage weeds to prevent weed waste and prevent the spread of seeds onto adjacent lands. See inspection photos for details.

Comment Topsoil stockpiles around the exterior of the permanent location fence appear to have been seeded and crimped and filtrex wattle installed around the perimeter base. However there is very little germination of desirable vegetation. The Operator noted June '24 seeding has occurred on the stockpiles. The stockpiles are growing kochia and puncturevine as well and should continue to be managed across the location. As a final note, filtrex wattles appear to have been installed incorrectly with single spaced staking and should be staked correctly.

The location will remain in-process and will have to be inspected during the active crop growing season to make an accurate assessment of vegetative conditions to ensure compliance per Rule 1003 standards.

Operator shall continue to monitor and manage this site until the location meets Rule 1003 standards, including stormwater and weed management. Operator shall submit a Form 4 Interim Reclamation Complete notice when the location meets Rule 1003 standards. ECMC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1003.
