On Tuesday, 09/10/2024, Inspector Kirby Burchett, conducted a routine field inspection at Antler Energy LLC on the Pole Gulch 6 well, Location #312865, in Moffat County, Colorado.

This location is within or in close proximity to a CPW District with High Priority, NSO, Density, and Other Consultation Habitat Regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal operations the following compliance issues were observed:

1. Exhaust risers open to wildlife.
2. Relief risers missing protective caps.
3. Spills and stained soil.
4. Open ended load line.
5. Noxious weeds.
6. Random debris.
7. Tank battery sign and well sign missing required information.

8. Review of production records indicate operator is delinquent in submitting monthly operations reports.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
