Well SKR-598-35-AV10 was plugged on 5/11 and at the same time we were moving from one system of scheduling (Generwell) to a new system of scheduling (Execute). During that migration some data was lost and our scheduling team did not receive the normal prompts to have the form submitted, but the work was already on the rig schedule. The rig went and executed the work and successfully plugged the well. In August it was realized that the well was missed and a form 42 was submitted retroactively. Due to this form being submitted, an inspector went out to the well and saw it was already plugged, prompting him to report a corrective action. Our engineering team (Gavin Snyder) has reached out to the states engineering team (Aaron Katz) and explained the situation, and the state expressed its understanding.
