Corrective Action: Final reclamation needs to be conducted per 1004 rules. Document #1716612 describes plugging the well on 11/2/2004. Final reclamation should have be conducted no later than 11/2/2005.

Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.

Operator Comment: Kinder Morgan submitted a Form 4 Sundry Notice requesting a Rule 502.b. surface owner final reclamation variance on 9/13/2017. ECMC approved the variance on 8/10/2020 and attached a Condition of Approval that was contrary to the intent of the surface owner variance request, noting that "graveling will increase the likelihood of erosion and runoff."  
  
Kinder Morgan recognizes and utilizes the application of gravel as a control measure to achieve final stabilization standards through its CDPHE Storm Water Permit. Kinder Morgan is engaged with outside counsel in order to prepare and resubmit a Rule 502.b. surface owner variance request in support of the surface owner's desired final land use, which is to retain an improved graveled surface for equipment storage.
