Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district.

The owner wants to keep all graveled roads. Weed spraying and reseedling was successfully completed in June 2024. However, due to unforeseen circumstances, including unusually dry conditions and lack of rainfall, weeds reemerged before a scheduled inspection. Given the approaching change in season, reapplying the spray before spring of 2025 would be inefficient. The land owner has requested that the gravel remain on site. The power poles seen on the edge of pad do not belong to pad and all signage has been removed.
