Location is within High Priority/Density/Black Bear Habitat areas & in close proximity to NSO Habitat area & Bald Eagle Roost Site.

Location is approximately 450 yards from Porcupine Creek.

While there, I observed workover rig performing casing repair on the SAVAGE RWF 411-26 well.

During this inspection the following compliance issues were observed:

1. Inspected Facilities - Failure to comply with COA on SAVAGE RWF411-26 well with a CA date of 9/18/2024

2. Inspected Facilities - Failure to comply with COA on SAVAGE RMV 149-26 with a CA date of 9/19/2024
