On Tuesday, 09/17/2024, Inspector Kirby Burchett, conducted a follow up field inspection at Scout Energy Management LLC on the Federal 12-6 well, Location #315117, in Rio Blanco County, Colorado.

This location is within or close proximity to a Parks & Wildlife (CPW) District with High Priority, NSO and Density Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issue observed during Insp. #702501927 on 10/2/23 and Insp. #702501589 on 6/29/23. The Corrective Action has been resolved by ECMC Engineering on 10/24/23 with the approval of an Aternate MIT.

While there during normal operations the following compliance issues were observed:

1. Debris
2. Staining
3. Unused equipment
4. Unlabeled chemical tank
