INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to provide prior notice of the closure of the State 2,7,26-16 production facility, the plugging and abandonment of the State 2, 8-16 wellheads, and the removal of the associated flowlines. The flowlines will be permanently removed. The off-location flowline systems pre-removal notice was submitted under Form 44 Document No. 403777164. In accordance with ECMC Rule 911.a., soil and groundwater (if present) samples will be collected and submitted for laboratory analysis to determine if concentrations and values are in compliance with ECMC Table 915-1. Visual inspection and field screening of soils following decommissioning of the associated infrastructure, wellheads and the associated flowlines will be conducted during sampling activities. Soil vapor screening will also be performed around each of the wellheads. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Following decommissioning activities, soil will be field screened at the facility infrastructure, wellheads, separators and wellhead flowline risers, and along the associated flowlines. Samples will be collected if indications of impacts to soil or groundwater are present. If impacted soils are encountered, a waste characterization soil sample will be collected from the areas exhibiting the highest degree of impact based on visual, olfactory, and/or field screening observations. In the absence of apparent impacts, a soil sample will be collected from the base of each of the wellhead excavations, adjacent to the wellhead and separator risers, and the areas most likely to have been impacted during the operational life of the flowlines and facility infrastructure. Soil samples will be submitted to an accredited laboratory for analysis using standard methods appropriate for detecting the target analytes in ECMC Table 915-1.

If groundwater is encountered during facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene (1,2,4 – TMB), and 1,3,5-trimethylbenzene (1,3,5 – TMB), using standard methods appropriate for detecting the target analytes in ECMC Table 915-1.

Following cut and cap operations, a soil gas survey will be conducted utilizing a maximum of five (5) soil vapor points located adjacent to the locations of the former wellheads. The proposed soil vapor point locations are illustrated on Figure 3. Proposed soil sample and screening locations are provided on Figures 2-4.
