Grab confirmation soil samples will be collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, where applicable. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

It is anticipated that excavation will be used to remove soil impacts in the unsaturated zone. After excavation has been completed, groundwater monitoring wells will be reinstalled and a remedial action will be formulated as necessary.

It is anticipated that excavation will be used to remove soil impacts in the unsaturated zone. After excavation has been completed, groundwater monitoring wells will be reinstalled and a remedial action will be formulated as necessary. Excavation will be conducted within 90 days of approval of this Form 27. The estimated time to NFA status is two years.
