This form has been prepared in accordance with ECMC Rule 911.a-c. to provide prior notice of closure of the Braukmann Farms 1-4 pits and production facility. Visual inspection and field screening of soils will be conducted following decommissioning of the associated infrastructure. Soil and groundwater (if present) samples will be collected and submitted for laboratory analysis to determine if concentrations and values are in compliance with ECMC Table 915-1. The topographic Site Location Map showing the geographic setting of the site as well as proposed soil sample map for the tank battery location are provided. Note: production facilities are to be closed under the Braukmann Farms 1-4 pit (Facility ID 116138).
