INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the STEPHENSON 06-31 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules and a sample was collected at the wellhead. Additional, soil samples were field screened along the N-E-S-W directions of the wellhead.

Approximately 1,765' of flowline was removed and 1,040' of flowline was abandoned in place and samples were collected at points of directional changes and midpoint along the previous flowline path (ECMC Form 44 Doc #403005982).

PROPOSED SAMPLING PLAN**Proposed Soil Sampling**

A (1) grab confirmation soil sample was collected at the wellhead excavation. Additionally, four (4) soil samples were collected at the point of abandonment (1), directional changes (2), and one along the midpoint of the previous flowline path. A sample at the separator will be collected at a future date. Soil samples were/will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron.

Proposed Groundwater Sampling

Groundwater was not encountered at the wellhead. If groundwater is encountered during future site investigations, a grab groundwater will be collected and analyzed for all organic compounds per ECMC Table 915-1.

Additionally, soil samples were field screened along the N-E-S-W directions of the wellhead and samples were collected at points of directional changes and midpoint along the previous flowline path.

Two (2) samples from the flowline displayed impacts greater than ECMC Table 915-1. Further analysis required to determine extend of impacts and will be proposed in a future 27.
