Comment The "Overall Status" of the Reclamation within interim areas of the Location is "in process", however, the slopes on the south/southeast end of the Location are predominantly bare soils; slopes lack stabilization and erosion degradation is evident.

Additional reclamation and stabilization efforts required within these areas of the Location.

Corrective Action Conduct additional reclamation in accordance with ECMC 1003 series rules. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Comply with Rule 1002.f and ensure erosion controls are implemented to stabilize the seeded soil.

Continue to monitor and manage this site until Final Reclamation has passed.
