On 07/30/2024 the P&A rig moved onto location to begin plugging the well. The Unit 20 plugging was completed on 8/9/2024 and cut/cap operations were completed on 8/14/24. Once the cut and cap was completed the well cellar was backfilled with excavated material. Chevron plans to excavate this Site during the 2025 field season. Pictures are attached.

The line was plugged with cement and the pipe was covered with dirt. The above description of the work completed on this flow line is part of the Wilson Creek Route 1 (Produced Water Injection) approved pre-abandonment plan submitted to ECMC in June of 2022. The form 44 Doc# 403069896 submitted with the following map has been approved by ECMC. Complete abandonment of the Wilson Creek Route 1 will accomplished before the end of the current work season at Wilson Creek. Pictures are attached.
