At the time of inspection, the field was plowed with organic fertilizer applied in preparation of wheat planting.

Comment: There is a small area of saltwater contamination with additional soil samples being analyzed to determine the lateral and vertical extent of contamination. The area was treated with organic material in conjunction with consultation with the landowner to augment fall wheat growth. Remediation plan will be timely submitted once the spill area is defined.
